Checklist:

	Request a date and time for the nikkah at the masjid. Contact any of the board members					
	of ICBCS to schedule the nikkah.					
	Obtain a marriage license from the county office. Note that this license becomes active					
	after 72 hours. Therefore, you must apply well in advance so that the license is active at					
	the time of the nikkah. The Imam will take this license from you and mail it to the					
	county office.					
	Fill out the ICBCS Marriage Declaration Form (included in this package) as soon as					
	possible to avoid any last minute errors or delays					
	Will the wali (guardian) of the bride be attending the nikkah?					
☐ If the wali will not be present, the Imam conducting the nikkah has to verify that t						
	has consented to the nikkah. Please allow extra time for this verification and let the					
	ICBCS management know about the absence of the wali and how he can be contacted.					
	Have the bridegroom and bride agreed on a Mahar for the nikkah?					
	Have they agreed on when and how the Mahar will be paid?					
	Identify two persons as witnesses to the nikkah. These persons must be present at the					
	nikkah, and should have a valid government issued photo identity at the time of nikkah.
